I further herby RELEASE, WAIVE, DISCHARGE AND PROMISE NOT TO SUE the Yucaipa Equestrian Arena Committee, the City of Yucaipa, California, and/or any of their employees, agents, participants or any entity or person connected with them during the activity, or any other person on the premises from any and all liability to the undersigned or my assigns, heirs and next of kin for any and all claims which may hereafter develop or accrue to me on account of, or by reason of, any injury, loss or damage which may be suffered by me and/or to my child, my ward or my invitee, or to my property because of any matter, thing or condition, negligence or default whatsoever, and I HEREBY ASSUME AND ACCEPT THE FULL RISK OF DANGER OF ANY HURT, INJURY OR DAMAGE WHICH MAY OCCUR REGARDLESS OF THE CAUSE.
4. I hereby expressly acknowledge and agree that ANY AND ALL ACTIVITIES ASSOCIATED WITH A HORSE OR HORSES ARE VERY DANGEROUS ACTIVITIES AND INVOLVE THE RISK OF SERIOUS BODILY INJURY AND/OR DEATH and/or property damage, and by signing this agreement Ido hereby expressly assume all risks.
